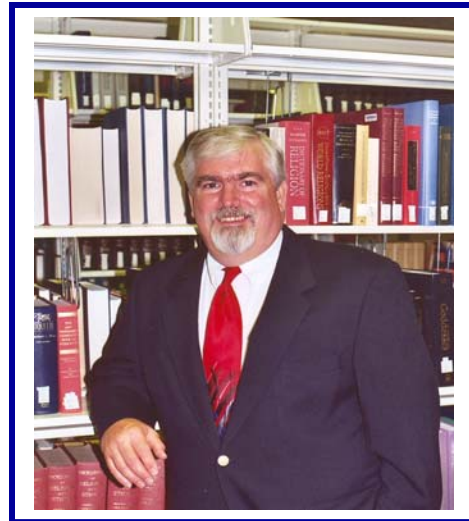
From the Desk of the Director:

Browse or search the IU Board of Trustees Minutes. As of April 17, 2007 the minutes available on the Web site included 1979-2006.

Created by the Indiana General Assembly in 1820, the [Board of Trustees](#) is Indiana University's governing board, legal owner, and final authority. The board holds the university's financial, physical, and human assets and operations in trust for future generations. Its membership, terms of office, responsibilities, powers, and electoral procedures are governed by the Indiana State Code. The current nine-member board meets nine times a year on various campuses around the state.

The Trustees minutes includes official acts, resolutions, policies, agreements, and other business records pertaining to the governance of [Indiana University](#). Also found are Administrative Action Reports (AAR) which were first included with the minutes in November 1987. Many of the minutes on this site include AAR, but some do not.

This Web site is the result of a cooperative project between the [Indiana University Digital Library Program](#), [Office of University Archives and Records Management](#) and the Board of Trustees office to provide access to a growing number of meeting minutes on the Web. The Archives houses the official paper copies of the minutes from 1835 to the present, except 1859-1883 which were destroyed in the campus fire of 1883 at the former location of Indiana University at Seminary Square.

Frequently Asked Questions About the Learning Enhancement Center's Upcoming Changes

1. *What prompted the administration to consider moving the LEC from the main building to the Kelly Center?*

Some of the motivation has been a long time in coming—the awareness that other campuses (IU Southeast, for example) successfully house their writing labs in their information commons located in the library and also feedback from the library staff that indicated students need and want help on their papers while they are researching and composing in the library. Other motivation has been more recent—the Math Department's decision to require online homework necessitated the creation of a lab with more computers than could be housed in the LEC.

2. *Where will the new writing lab be located, and what services will it provide?*

The writing lab will be housed in what used to be the “Media Viewing Room” in the library. It is currently being remodeled based on the new lab's needs, and the tutors will continue to provide a variety of support for students as they work on papers, i.e. assess assignment guidelines, develop ideas, draft, revise, edit or cite in the required documentation style.

3. *What provisions have been made to continue or relocate other services that the Learning Enhancement Center presently provides?*

Spanish tutoring will take place in the new writing lab; all other services (placement testing, foreign language placement testing, C100 test-out exam, special needs testing, ETS Testing for English majors, and proctoring of make up exams for faculty) will be taken over by Continuing Education which will now be housed in the present LEC K0 280.

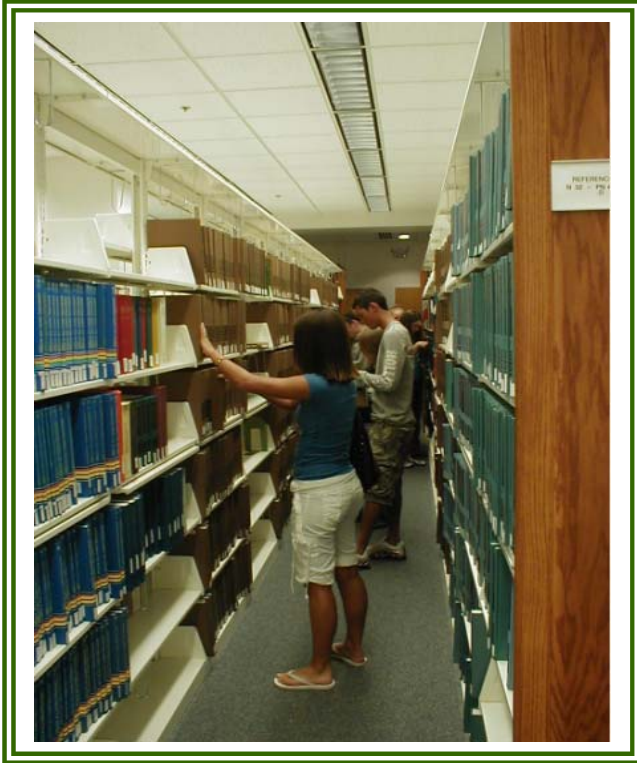
4. *What are the projected dates for the move?*

The new writing lab will be ready for the fall semester, and until then all testing and tutoring services will be provided over the summer by the current LEC staff.

5. *What consideration has been made for students who used the LEC as an area to check e-mail, study, eat or informally gather?*

It is certainly acknowledged by administration, faculty and students alike that the LEC provides a welcoming atmosphere where students feel comfortable just “hanging out” in addition to being productive. However, because some students required a quiet space for tutoring, there was tension between the productive and the social roles of the LEC. With the creation of the new writing lab and through existing social spaces such as the lounge in KO 170, everyone's needs will be met. In addition, campus administration has met with students and will take up their request to provide access to printing in the student lounge in the Main Building. Students will also want to know that printing and scanning are available to them in the Curriculum Lab across from the Student Lounge that is in KO #170.

Future IU Kokomo Students Learn to Use the Indiana University Libraries



This semester, high schools from throughout the IU Kokomo service area – Kokomo, Logansport, Peru, Rochester, North Miami – took advantage of an opportunity to visit the campus library to make use of its resources for end-of-the-semester projects and term papers.

These students receive IU Library cards, a one-day guest computer account to access the Library's online databases, and an overview by one of the campus librarians about which of the online and print resources would be best suited for their particular project.
